5. **Croatian Open Masters Championship is an official sports competition, therefore all participants — registered and unregistered alike — are considered athletes within the meaning of Article 8 of the Croatian Sports Act (NN 141/22). All participants are therefore required to submit a valid Certificate of Medical Fitness for Athletes by Thursday 1 October 2026 to ured@croswim.org (Article 15(1) of the Sports Act; Article 6 of the Ordinance on Medical Examinations of Athletes, NN 27/26). Without a submitted certificate, participation in the competition is not possible.**
6. Relay entries are accepted by e-mail at ured@croswim.org or at the recording desk during the technical meeting.
